

## Candidate Statement for the 2020 ACT Election

The Candidate Statement is to give voters information to guide their selection of candidates based on the candidate's ability to be an MLA and their commitment to strengthen the democratic fabric of the ACT.

My name is **Tim Dobson** and I am a candidate for the ACT Legislative Assembly in the electorate of **Murrumbidgee**.

My work has created jobs and supported people from childhood to adulthood to get set up for fulfilling lives.

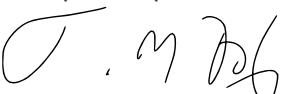
- Employ deliberative democracy where possible, to maximise the community's say in governance.

**If elected, I will undertake these measures to promote and improve informed participation by my constituents in ACT policy development and decision making. (Up to 50 words, dot points, in 10pt Arial font)**

- Apply Asset Based Community Development principles in any engagement with the community.
- Facilitate greater involvement of community members who are traditionally left out of community consultation: public housing tenants, migrants and refugees, people with disabilities and their carers, single parents, people with mental health issues, unemployed workers and young people.

1. I will strictly abide by the ACT Legislative Assembly Standing Orders Code of Conduct for MLAs.
2. I will fully disclose and make public the sources and value of all political funding donations, contributions, gifts public and private towards my election campaign and political activity, within one month of receipt.
3. I will place the public interest (the welfare and wellbeing of the general population and the integrity of the planet) ahead of sectional, corporate, personal, religious or other interests.
