4. Annual Report – achievements summary presented at the meeting

Genuine Citizen participation - how to get citizen voice (citizen generated wisdom) into the ACT Assembly

- Explored different models of citizen deliberation in Canberra and elsewhere and what it takes for these processes to be legitimate. Used Deliberate ACT to extend learning to a wider audience
- Encouraged the ACT Government to approach the Review of the Territory Plan in a way that built trust unfortunately our advice was not taken and we learnt that it is difficult for government to shift from "power over"
- Used our reflections on the four Deliberative Processes in 2018 to deepen our understanding of citizen deliberation shared in newsletter.
- Gave presentations on the wellbeing indicators and also a public forum on the OstBelgian model for permanent citizen deliberation and in the process built collaborative working relations with academics at University of Canberra (IGPA, NATSEM) and ANU.

- Generated conversations and collected people's opinions about MLA roles at Southfest 2018
- Delved deeply into the question "how do MLAs go about the job of representing" (MLA Interviews – as a basis for a Statement of Expectations for MLAs)

- Exploring the idea of the Active Citizen
