## CAPaD's future activity focus

23 October @ 14:00 AEST

You are warmly invited to a conversation about the focus of future activity for CAPaD in the context of more overtly moving to being an education charity.

### **Purpose:**

To explore members views about the reasons for and implications of:

- establishing the Awakening Democracy Foundation to receive tax deductible donations for educational charity purposes;
- consequent key word changes in the objects in the CAPaD constitution (as per AGM proposal) from government to parliament, or some other wording, so that the objectives reflect our current focus;
- scope other possible constitutional changes to reflect our evolving activity focus; and
- members being involved in various action learning projects bringing democracy to the people

#### **Canberra Forum**

The Canberra Forum is a citizens' assembly, initially to be run over 2023, with about 40 Canberrans randomly selected from the electoral roll to be involved. These participants will together identify two topics that they from a survey of all possible participants. The Forum will deliberate on these topics and report to Alicia on the outcomes. Alicia has committed to acting on the reports.

We are working with Alicia Payne and DemocracyCo to see what our role with the Canberra Forum might be. This might be helping to orient observers and reflecting on the process, using our Genuine Engagement Tool.

A major outcome is to have a toolkit prepared so that other MPs and electorates can set up similar assemblies.
